COMPANY OVERVIEW

This non-profit regional health care system includes a medical center, 15+ primary care clinics and dozens of specialty care clinics. There are approximately 500 beds and 6,400 team members with approximately 1.8b in annual patient revenue. They are currently on PeopleSoft 9.1 Financials and Supply Chain and have been running PeopleSoft for almost 7 years.



THE LIST OF ISSUES WAS EXTENSIVE AND THESE ARE JUST A FEW THAT WERE IDENTIFIED AND RESOLVED.

1. Lack of understanding regarding how to work errors and exceptions in the financial and supply chain Modules. For example, Matching, Sourcing and locked Processes

3. Didn't have visibility to transactions stuck in process and how to resolve them.
4. Didn't have the reporting that was needed because they didn't know which tables are needed, the logic to use and how to build them.
